SUBJZCT: PRESIDENTIAL SUCCESSION

1. OPPOSITION PARTY MDB APPEARS IN THROES OF DECIDING WHETHER OR NOT TO RUN CANDIDATE IN PRESIDEMTIAL ELECTION, WITH GENERAL AMAURY KRUEL CURRE TLY RUNNING BLUFF AS POTENTIAL MDB CANDIDATE TO TRY TO SQUEEZE GOVERNMENT ON ELECTORAL DOMICILE ISSUE.

2. MDB PRESENTLY SPLIT INTO SEVERAL SCHOOLS OF THOUGHT WITH RESPECT PRESIDENTIAL RACE. ONE SCHOOL FAVORS RUNNING CANDIDATE BUT FROM CIVILIAN SIDE TO HIGHLIGHT MILITARY ASPECT COSTA E SILVA CANDIDACY. SECOND SCHOOL WOULD REFUSE PARTICIPATE IN ANY WAY IN PRESIDENTIAL ELECTORAL PROCESS IN EFFORT DEMONSTRATE THAT IT UNDEMOCRATIC FARCE. THIRD SCHOOL URGES PARTY HOLD SELF READY TO SUPPORT COSTA E STLVA ON CONDITION HE COMMIT GOVERNMENT TO RETURN TO CONSTITUTIONAL NORMALCY. THERE ALSO OBVIOUSLY IS FRICTION THAT WOULD ACCEPT GENERAL KRUEL IF HE MADE SELF AVAILABLE.

3. DURING PAST SEVERAL DAYS, THERE HAS BEEN VERITABLE CIRCUS OVER MDB ALLEGED OVERTURES TO SECOND ARMY COMMANDER GENERWL KRUEL TO BE ITS CANDIDATE. DESPITE DENIALS AND COUNTER-DENIALS DN PART ALL PARTIES CONNCERNED, THERE APPEARS BE SOME FIRE UNDER (MOKE. GENERAL KRUEL IS PROBABLY MOST IMPORTANT MILITARY FIGURE IN COUNTRZ SHOWING INTEREST IN RUNNING FOR PRESIDENT ON MDB ICKET. (GENERAL MOURAO FILHO HAS ANNOUNCED AVAILABILITY, BUT 'E LACKS PRESTIGE OF ACTIVE COMMMAND.) AT SAME TIME, KRUEL

STUBBORNLY PERSISTS IN EFFORTS TO SECURE REVISION OF TWO-YEAR ELECTORAL DOMICILE FOR GUBERNATORIAL CANDIDATES TO CLEAR PATH FOR HIS CANDIDACY VOVERNORSHIP SAO PAULO.99

N MILITARY, WHICH UNLIKELY, AND TE UNQQESTIONABLY PREFERS SAO PAULO GOVERNORSHIP, HE AND MDB SEEM BE COLLUKING (LATTER PERHAPS SIMPLY AS EXPLORATORY, PRMBING OPERATION TO SEE IF ANYTHING CAN BE STIRRED UP) IN RUNNING A BLUFF ON ADMINISTRATIMN HEMBASSY ESTIMATES ADMINISTRATION WIL CALL BLUFF BY DEFEATING PASSAGE OF MDB-SPONSORED CONSTITUTIONAL AMENDMENT NOW BEFORS CONGRESS WHICH WOULD EXEMPT MILITARY COMMANDERS (AND OTHERS) FROM ELECTORIAL DOMICILE REQUIREMENT. IF GOVERNMENT CAVED ON THIS ISSUE, WOULD NOF OBANNESSEBIVUGUADMASS@OOPEN DOORK TO HOST OF MILITARY CANDIDATES AT VARIOUS LEVELS THROUGHOUT COUNTRY. THAT FACTION OF MDB WHICH INTERESTED IN KRUUL CANDIDACY APPARENTLY BELIEVES HE IS STRONREST CONTENDER PARTY COULD GET TO MAKE BEST POSSIBLE, IF UNSUCCESSFUL, SHOW AT PRESIDENTIAL ELECTION.
