SUBJECT: REPORTS BRAZILIAN MILITARY CONFIDENT U.S. SUPPORT

- 1. SANTOS MAYOR-ELECT ESMERALDO TARQUINIO TOLD CONGEN OFFICER DECEMBER 21 THAT BRAZILIAN MILITARY MEN ARE SPREADING REPORTS THAT U.S. MILITARY MEN FULLY SUPPORT EXTRAORDINARY ACTION BEIN TAKEN FIGHT SUBVERSION IN BRAZIL. THEY ALLEGING ASSUR-ANCES WERE GIVEN DURING RECENT INTER-AMERICIN MILITARY CON-FERENCE RIO DE JANEIRO. TARQUINIO BELIEVES STORIES BEING SPREAD TO BUILD MILITARY MORALE AND DEMORALIZE OPPOSITION.
- 2. BRAZILIAN ARMY MAJOR TOLD CONGEN LOCAL EMPLOYEE THAT BRAZILIAN MILITARY MEN CONFIDENT OF U.S. UNDERSTANDING AND SUPPORT DESPITE ANY PUBLIC STATEMENTS BY U.S. "CIVILIANS."
- 3. SIMILAR ATTITUDES WERE EXPRESSED TO CONGEN OFFICER IN SEPARATE CONVERSATIONS BY EXTREME HARD-LINE AIR FORCE OFFICERS LT. COLONEL JULIO VALENTE, CHIEF LEGAL DEPARTMENT 4TH AIR ZONE, AND MAJOR FRANCISCO RENATO DE MELLO, INTELLIGENCE CHIEF 4TH AIR ZONE. THESE OFFICERS APPEARED HARBOR NO DOUBTS THAT U.S. WOULD FULLY SUPPORT MEASURES TAKEN UNDER IA-5. THEY DISCOUNTED PRESS ACCOUNTS THAT U.S. OFFICIALS PRIVATELY UNAPPY OVER EVENTS IN BRAZIL AS FABRICATIONS LEFT LEANING U.S. NEWS MEDIA. SEEMED REMAIN UNCONVINCED WHEN CONGEN OFFICER SAID U.S.G. UN-HAPPY OVER SITUATION IN BRAZIL.
- 4. COMMENT: CONGEN CURIOUS AS WHETHER INSTANCES MENTIONED PARA-GRAPHS ONE AND TWO ABOVE ARE ISOLATED INSTANC

S OR WHETHER THEY REPRESENT PART OF EFFORT TO REASSURE MILITARY CONTINUED U.S. SUPPORT AND UNDERSTANDING. CLEARLY, WITH REFERENCE IA-5. HARD-LINERS SUCH AS MAJOR DE MELLO AND COL. VALENTE APPEAR CONSIDER IT AS PANACEA FOR BRAZIL'S PROBLEMS.
